

NOTICE OF PUBLIC HEARING

PROPOSED SERVICE CHANGES:
GET ABOUT & GET ABOUT EXTENDED FARE INCREASE
REDUCTION TO OPERATING HOURS
CONCLUSION OF THE ONE STEP OVER THE LINE PROGRAM

Proposed Changes Effective July 1, 2025:

Due to an approximate increase of 50% in operational costs, Pomona Valley Transportation Authority is proposing the following service changes. Proposed changes include a fare adjustment for the Get About and Get About Extended programs, a reduction in operating hours, and the discontinuation of the One Step Over the Line program. A public hearing will be held to gather community input on these proposed service changes.

1. Get About & Get About Extended Service Fare Increase-Get About provides service within the cities of Claremont, La Verne, Pomona, and San Dimas. The current fare for Get About trips originating and ending within this service area is **\$1.00 per one-way trip**. The proposed change would increase this fare to **\$2.75 per one-way trip**. Get About also offers extended service to areas west of the regular service area — specifically, as far as Grand Avenue between the I-10 Freeway (south) and Foothill Boulevard (north). Riders must begin their trip within the regular service area to use this extension. The fare for trips in this extended area would increase from **\$2.00 to \$3.75 per one-way trip**.

2. Reduction in Operating Hours- PVTA is proposing a reduction in the operating hours for both Get About and Ready Now services. A revised schedule is shown below, reflecting these changes.

3. Conclusion of One Step Over the Line Program – As part of PVTA's ongoing efforts to evaluate and improve service efficiency, the One Step Over the Line program will be concluded. PVTA remains committed to supporting affected riders by helping them explore and transition to alternative transportation options that best meet their needs.

Public Hearing Details- In accordance to Title VI hearings will be held to propose the service changes. All interested persons are invited to attend and provide input.
