

## NOTICE OF PUBLIC HEARING

### PROPOSED SERVICE CHANGES:

#### **CLAREMONT DIAL A RIDE REDUCTION OF OPERATING HOURS**

#### **CLAREMONT DIAL A RIDE FARE CHANGES FOR GENERAL PUBLIC ONLY**

#### **Proposed Changes Effective August 1, 2026:**

The Pomona Valley Transportation Authority, in coordination with the City of Claremont, is proposing a modification to the Claremont Dial A Ride (DAR) service. As part of PVTA's ongoing efforts to evaluate service performance and align service levels with community needs, PVTA is proposing the following change. A public hearing will be held to gather community input on the proposed service adjustment.

#### **1. Reduction in Operating Hours\***

Claremont Dial A Ride (DAR) currently operates 24 hours per day, 7 days per week. PVTA is proposing to adjust the service hours to better align with rider demand and improve operational efficiency.

- **Current Service:** 24 hours per day, 7 days per week
- **Proposed Service:** Approximately **7:00 AM to 8:00 PM, 7 days per week**

#### **2. Increase General Public Fare\***

Claremont Dial A Ride (DAR) current General Public fare is \$2.50 within Claremont and \$4.00 outside of city boundaries. PVTA is proposing to increase the General Public fare only to better align with increasing costs and containment strategies.

Fare Type	Current Fare	Proposed Fare
General Public <i>within</i> Claremont	\$2.50	\$4.50
General Public <i>outside</i> of Claremont	\$4.00	\$7.00

*\*Please note that the proposed service and fare changes are not final and may be adjusted based on public feedback and coordination with other service areas.*
